1. a) The breeder will do breeding under a kennel name recognized by the U.R.C.S.H. or by an equivalent foreign company affiliated to the F.C.I.
b) An occasional breeder may, in agreement with the B.P.D.C., apply for a derogation on this point (1.a).
2. The breeder will do breeding which conform to the English breed standard (F.C.I.)
3. The breeder will join to the BPDC's status.
4. By selecting male dogs and bitches to match, the breeder will strive to improve the breed, focusing on control - or even better by eradication - hereditary defects.
5. A bitch should be at least 15 months of age before mating for the first time.
6. A bitch should not have more than 1 litter every 12 months.
7. A bitch should not be mated once she has reached the age of 6 years.
8. Puppies should not leave their mom and littermates before 10 weeks of age and they will have been vaccinated, dewormed and identified with a tattoo or a microchip. According to the breeder's decisions, the puppy will leave the litter at the age of 10 weeks or he will keep it until the age of 12 weeks.
9. The puppies are raised in families. Pugs never live in a doghouse, a cage or in kennels, but only in the breeder's house.
10. a) The breeder will never sell a dog to a buyer when he can reasonably believe that he/she will sell the dog;
b) The breeder will never sell a dog to a buyer when he can reasonably believe that the dog will be used for breeding at odds with this code of ethic.
11. The breeder will only breed dogs (male or female) who have obtained at least 2x VG qualifications (VG = Very Good) during clubmatches organized by organizations that defends the interests of the breed or under the aegis of the FCI or during dogshows organized by the U.R.C.S.H.
12. a) The breeder won't breed with cross breeding, mongrel or non pedigree dogs
b) The breeder will only breed 1 other type of dog breeds recognized by the F.C.I. (in addition to the pug).
13. The puppy sale contract should be accompanied by a well-written contract establish by the breeder, which contains at least the terms established by the B.P.D.C. in its standard contract or will use this standard contract. This written contract will be signed and dated by the seller and the buyer. The Buyer will keep the originally signed contract and the seller will have a copy.
14. The male dog to be used is as good an example of the breed as possible and suitable for breeding under guidelines 4, 5 and 6 above of this code of ethics. The breeder will draw up a declaration with all the above points and will have it signed by the owner of the bitch.
15. A male dog should be at least 12 months of age before mating for the first time.
16. The male dog will stop mating as soon as he will reach the age of 9 years old. In exceptional circumstances and with the consent of the B.P.D.C.'s committee, a slightly older male dog may be allowed to practice a mating.
17. If the breeder does not agree to any of the terms of this Code of Ethic, the breeder is prohibited from becoming or remaining to be a B.P.D.C.'s member.
18. In the event of non-compliance and/or violation of the above guidelines, the B.P.D.C.'s committee should apply appropriate sanctions :
 - Warning
 - Reprimand
 - Exclusion
